How does an apprentice get registered?

*The apprentice registers on their own online within 30days of working for the electrical contractor. Mail in registration are no longer accepted. The apprentice receives a registration number, that number is given to the contractor. Contractor can add or remove apprentice from contractor list online . The apprentice can be tracked at all times through this number.

2011 NEC, 210.12. Extending lighting circuit in a kitchen, is this circuit still required to be AFCI protected?

*210.12.B, addresses extension and modification of these circuits. If this circuit is modified from the kitchen switch, it is not required to be AFCI protected under this code cycle. Recommended to reference definitions.
